Nick Nichols, one of multiple chairs of the sailing school committee reported on the summer session. He said the school ended up in the black even though it got only 69 students, rather than the 78 called for in the budget.

The summer was somewhat challenging because one instructor moved to Florida. But head Erin Kenyon xxx kept operations going. Fund-raisers, including the pancake breakfast, run by George and Nancy Kinser for the tenth straight year, and the auction helped balance the budget. Sandy Nelson reported membership is full at 260, with 21 people on the waiting list including three singles and nine couples. The club welcomed 17 new regular members in the past year, up from 11 the year before.

Membership inquiries have been scant recently, and only seven new applicants joined the waiting list this past year. Sandy said prospective members often have trouble finding two unrelated sponsors among current members. Sponsors have to have been members for a year, and they can sponsor one person or couple annually.

Kristin Fletcher reported for the reorganized Finance Committee, which has ten members and has an ambitious agenda to update the Club's longterm budgeting process and modernize its accounting.

Howard Levitan is leading a transition to Online QuickBooks from the outdated PC-based software the club has been using. One goal is to be able to make and receive payments electronically. The club is using a consultant to aid in the move.

Bob Seaman reported for the Building & Grounds Committee that the club has ordered a new AED defibrillator for the clubhouse.


Paul Cournoyer, reporting for the Waterfront Committee said that floats will be removed Oct. 10, so all dinghies should be off the floats by Oct. 8.

Joyce Duda, who is retiring after many years as Social Committee chair, said that some new events this year had been very successful, including the sail day on the schooner Alert, donated by the Davises, and the new monthly Casual Friday.

She said the Italian Dinner was the most heavily attended event, but the Lobster Bake attendance was down sharply from past years.
